Supplier Requirements

All suppliers must meet the following criteria:

Requirement	Description
KRA Registration	Be registered as a taxpayer with a valid KRA PIN.
Tax Compliance	Possess a valid Tax Compliance Certificate from KRA
Sole Proprietorships	Provide a current Certificate of Good Conduct, guaranteeing the absence of criminal and fiscal proceedings.

How to Apply

Interested suppliers should submit the following:

- A letter of interest stating the category of supplies you wish to tender for and your terms and conditions.
- Copies of all necessary legal documents (KRA PIN, Tax Compliance Certificate, Certificate of Good Conduct).
